(57) **ABSTRACT**

This disclosure may relate generally to systems, devices, and methods for a injecting a solid compound in line with a pressurized fluid, through a sootblower burner or other utility furnace hardware, such that the compound can be delivered to targeted areas on the inside of a utility furnace.
